

ORDINANCE 12-05

AN ORDINANCE PROVIDING FOR BULK PICK UP SERVICES; THE BILLING AND PAYMENT FOR BULK PICK UP SERVICES; FOR PROCEDURES TO BE FOLLOWED IN THE EVENT OF NONPAYMENT FOR BULK PICK UP SERVICES; AND DECLARING AN EMERGENCY AND OTHER PURPOSES

WHEREAS, the City of Cammack Village, for a fee provides trash collection services for home owners in Cammack Village, Arkansas, of which the billing and payment procedures are as set forth in Ordinance 07-08; and

WHEREAS, the City of Cammack Village, for an additional fee (which shall be charged and included with the fee charged by the City of Cammack Village for trash collection services) desires to add a bulk pick up service for its residents; and

WHEREAS, the City of Cammack Village desires to establish payment and collection procedures for the providing of a bulk pick up service to its residents.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMMACK VILLAGE:

SECTION 1: Bulk Pick Up Service Provided by the City of Cammack Village. The City of Cammack Village shall offer to each residence within Cammack Village one (1) curbside bulk pickup per year of up to three (3) cubic yards. If said bulk pick up exceeds three (3) cubic yards additional fees will apply as set forth in Section 2 below. Information regarding the bulk pick up process and the scheduling thereof can be obtained from the City Hall of Cammack Village.

SECTION 2: Fee Charged by Cammack Village for Bulk Pick Up Service. The City of Cammack Village shall charge a fee of \$2.36 per month as to each residence within Cammack Village for bulk pick up service. The monthly amount thereof as to such bulk pick up service shall be added on and included with the monthly fee that is charged each resident for trash collection services and shall be paid in accordance with the procedures set forth within Ordinance 07-08. In the event said bulk pick up exceeds three (3) cubic yards, said resident shall separately pay to the City of Cammack Village an additional \$7.89 per cubic yard to cover the expense of said bulk pick up items that exceed three (3) cubic yards.

SECTION 3: Procedures in Place so as to Pay for Bulk Pick Up Services. The monthly bulk pick up fee (which shall be included as part of the monthly trash collection fees) shall become due and payable at the beginning of each quarter. These charges may be paid without penalty at any time during the quarter or prior to the close of the first day of the month of the next ensuing quarter. After the close of the first day of the month of the next ensuing quarter, an additional penalty of \$5 for each quarterly payment as to such bulk pick up fee will be imposed for each quarter or portion thereof during which such bulk pick up fee (or fees) remain unpaid.

SECTION 4: Responsibility of Property Owner as to the Payment of Bulk Pick Up Fees. It is the sole responsibility of the owner of the residence to pay the bulk pick up fee, including all penalties that may accumulate. Irrespective herein, the City of Cammack Village will accept payments from the current resident of the property without waiver of the property owner's responsibility for payment of any amounts not paid by the current resident.

SECTION 5: Failure to Pay the Bulk Pick Up Fee and Enforcement of Delinquent Payments Associated Therewith. Failure to pay the bulk pick up fee, will subject the property owner to collection procedures as put into place by the City Clerk of Cammack Village. The City of Cammack Village and the City Clerk to enforce the payment of such bulk pickup fees shall follow the same procedures as outlined in Sections 4 through 7 of Ordinance 07-08 as such applies to the collection procedures in place for trash collection services.

SECTION 6: Repeal. This ordinance repeals any other prior ordinance to the extent such other ordinance is in conflict with this ordinance as to any part.

SECTION 7: Emergency Clause. The City Council for the City of Cammack Village finds and determines that the implementation of a bulk pick up service and the collection of fees to provide for such service as set forth above are essential for the orderly administration and operation of the City of Cammack Village, Arkansas and an emergency is declared to exist, and this ordinance being necessary for the preservation of the public peace, health and safety shall be in full force and effect on and after January 1, 2013.
