

ORDINANCE 14-04

AN ORDINANCE REVISING ORDINANCE 13-06 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2014 THROUGH DECEMBER 31, 2014 FROM THE GENERAL FUND FROM THE AMOUNT OF \$457,545 TO THE AMOUNT OF \$438,610; FROM THE AMOUNT OF \$233,339 TO THE AMOUNT OF \$217,000 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$3650 TO THE AMOUNT OF \$4,000 FOR THE FIRE DEPARTMENT; THE AMOUNT OF \$82,110 FOR THE SANITATION DEPARTMENT; FROM THE AMOUNT OF \$9,000 TO THE AMOUNT OF \$7,000 FOR THE PARKS AND RECREATION DEPARTMENT (EXCLUDING SWIMMING POOL); FROM THE AMOUNT OF \$7,000 TO THE AMOUNT OF \$13,500 FOR THE SWIMMING POOL FUND; FROM THE AMOUNT OF \$114,446 TO THE AMOUNT OF \$108,000 FOR THE ADMINISTRATION DEPARTMENT; THE AMOUNT OF \$7,000 FOR SALES TAX; ALL PREVIOUSLY DESIGNATED DEPARTMENTAL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN AMENDING APPROPRIATION FOR THE STREET FUND FROM THE AMOUNT OF \$57,050 TO THE AMOUNT OF \$80,000; AN AMENDING APPROPRIATION FOR THE SWIMMING POOL FUND FROM THE AMOUNT OF \$53,500 TO THE AMOUNT OF \$63,000; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to amend the funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2014 and ending December 31, 2014.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas;

SECTION 1: That funds for the fiscal year, beginning January 1, 2014, and ending December 31, 2014, are hereby amended and appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth.
