CITY COUNCIL

The City Council met on Tuesday, October 11th. The Council had three items of new business on the Agenda. The Council first appointed John Metrailler to the Urban Service District Board to serve out the term vacated by John Mallory. Next, they approved Ordinance 16-03, which is attached. Ordinance 16-03 approves the yearly real and personal property tax levy for 2016. This is not a new levy but a continuation of the existing levy. The Council then approved Resolution 16-01 which allows for the City to start accepting credit and debit cards as form of payments.

ORDINANCE 16-03

AN ORDINANCE TO ESTABLISH THE RATES OF TAXATION TO BE LEVIED ON TAXABLE REAL AND PERSONAL PROPERTY IN THE CITY OF CAMMACK VILLAGE, ARKANSAS FOR THE TAX YEAR 2016; REPEALING ALL ORDINANCES OR RESOLUTIONS IN CONFLICT HEREWITH; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.

WHEREAS, the City Council of the City of Cammack Village deems it necessary and appropriate to establish the tax rate for general purposes to be levied on all taxable real and personal property for the 2016 tax year.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF CAMMACK VILLAGE, ARKANSAS:

SECTION 1: Tax Rate on Real Property. The tax rate for general purposes to be levied on all taxable real property as of the assessment date of January 1, 2016, in Cammack Village, Pulaski County, Arkansas for the tax year 2016 shall be 5.0 mills as applied to assessed valuation.

SECTION 2: Tax Rate on Personal Property. The tax rate for general purposes to be levied on all taxable personal property as of the assessment date of January 1, 2016, in Cammack Village, Pulaski County, Arkansas for the tax year 2016 shall be 5.0 mills as applied to assessed valuation.

SECTION 3: Repeal. All ordinances and resolutions in conflict herewith are specifically repealed.

SECTION 4: Emergency Clause. The City Council of the City of Cammack Village, Arkansas finds and determines that an ordinance adopting the rates of taxation to be levied on taxable real and personal property is necessary for the orderly administration and operation of the City of Cammack Village, Arkansas; an emergency is declared to exist and this Ordinance being necessary for the preservation of the public peace, health and safety shall be in full force and effect on and after the 11th day of October, 2016.
