

**ORDINANCE NO. 00-5**

**AN ORDINANCE APPROPRIATING FUNDS FOR THE FISCAL YEAR JANUARY 1, 2001 THROUGH DECEMBER 31, 2001 FROM THE GENERAL FUND IN THE AMOUNT OF \$377,260; THE SUM OF \$133,205 FOR THE POLICE DEPARTMENT; THE SUM OF \$6000 THE FIRE DEPARTMENT; THE SUM OF \$7500 FOR THE PARKS AND RECREATION DEPARTMENT; THE SUM OF \$5000 FOR THE SWIMMING POOL; THE SUM OF \$68,500 FOR THE SANITATION DEPARTMENT; THE SUM OF \$155,555 FOR THE ADMINISTRATION DEPARTMENT; THE SUM OF \$1500 FOR MISCELLANEOUS EXPENSES; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND. AN APPROPRIATION FROM THE STREET FUND IN THE AMOUNT OF \$57,250; INCLUDING THE SUM OF \$10,500 FOR C.A.T.A.; AND APPROPRIATION OF \$57,527 FROM THE SWIMMING POOL FUND; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.**

Whereas, it is necessary to appropriate funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2001 and ending December 31, 2001.

**NOW, THEREFORE, BE IT ENACTED** by the City Council of the City of Cammack Village, Arkansas:

**SECTION 1:** That funds for the fiscal year, beginning January 1, 2001 and ending December 31, 2001 are hereby appropriated from the General Fund, Pool Fund, and the Street Funds in the amount and for the departments as hereinafter set forth:
