

ORDINANCE 01-07

AN ORDINANCE REVISING ORDINANCE 00-04 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2001 THROUGH DECEMBER 31, 2001 FROM THE GENERAL FUND FROM THE AMOUNT OF \$377,260 TO THE AMOUNT OF \$442,000; FROM THE AMOUNT OF \$133,205 TO THE AMOUNT OF \$160,000 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$6,000 TO THE AMOUNT OF \$13,000 FOR THE FIRE DEPARTMENT; THE AMOUNT OF \$7,500 FOR THE PARKS AND RECREATION DEPARTMENT; FROM THE AMOUNT OF \$5,000 TO THE AMOUNT OF \$12,000 FOR THE SWIMMING POOL; FROM THE AMOUNT OF \$68,500 TO THE AMOUNT OF \$85,000 FOR THE SANITATION DEPARTMENT; FROM THE AMOUNT OF \$155,555 TO THE AMOUNT OF \$163,000 FOR THE ADMINISTRATION DEPARTMENT; THE AMOUNT OF \$1,500 FOR MISCELLANEOUS EXPENSES; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND, AN APPROPRIATION FROM THE STREET FUND FROM THE AMOUNT OF \$57,250 TO THE AMOUNT OF \$77,000, INCLUDING THE AMOUNT OF \$10,500 FOR CATS; AND APPROPRIATION FROM THE SWIMMING POOL FUND IN THE AMOUNT OF \$57,527 FOR THE SWIMMING POOL; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES

WHEREAS, it is necessary that an amendment of the funds to be appropriated for the operation of various departments of the City of Cammack Village for the fiscal year beginning January 1, 2001 and ending December 31, 2001 be made.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas:

SECTION 1: That funds for the fiscal year, beginning January 1, 2001 and ending December 31, 2001 are hereby amended and appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth:


