

AN ORDINANCE APPROPRIATING FUNDS FOR THE FISCAL YEAR JANUARY 1, 2002 THROUGH DECEMBER 31, 2002 FROM THE GENERAL FUND IN THE AMOUNT OF \$406,767; THE SUM OF \$139,212 FOR THE POLICE DEPARTMENT; THE SUM OF \$13,000 FOR THE FIRE DEPARTMENT; \$139,212 FOR THE POLICE DEPARTMENT; THE SUM OF \$13,000 FOR THE FIRE DEPARTMENT; THE SUM OF \$9,000 FOR THE PARKS AND RECREATION DEPARTMENT; THE SUM OF \$10,000 FOR THE SWIMMING POOL; THE SUM OF \$77,700 FOR THE SANITATION DEPARTMENT; THE SUM OF \$156,855 FOR THE ADMINISTRATION DEPARTMENT; THE SUM OF \$1,000 FOR MISCELLANEOUS EXPENSES; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND. AN APPROPRIATION FROM THE STREET FUND IN THE AMOUNT OF \$59,400; INCLUDING THE SUM OF \$10,500 FOR C.A.T.A.; AND APPROPRIATION OF \$59,400 FROM THE SWIMMING POOL FUND; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to appropriate funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2002 ending December 31, 2002.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas:

SECTION 1: That funds for the fiscal year, beginning January 1, 2002 and ending December 31, 2002 are hereby appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth:




