

AN ORDINANCE REVISING ORDINANCE 01-08 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2002 THROUGH DECEMBER 31, 2002 FROM THE GENERAL FUND FROM THE AMOUNT OF \$406,767 TO THE AMOUNT OF \$412,767; FROM THE AMOUNT OF \$139,212 TO THE AMOUNT OF \$141,212 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$13,000 TO THE AMOUNT OF \$17,000 FOR THE FIRE DEPARTMENT; THE AMOUNT OF \$9,000 FOR THE PARKS AND RECREATION DEPARTMENT; THE AMOUNT OF \$10,000 FOR THE SWIMMING POOL; THE AMOUNT OF \$77,700 FOR THE SANITATION DEPARTMENT; THE AMOUNT OF \$156,855 FOR THE ADMINISTRATION DEPARTMENT; THE AMOUNT OF \$1,000 FOR MISCELLANEOUS EXPENSES; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND, AN APPROPRIATION FROM THE STREET FUND IN THE AMOUNT OF \$59,250, INCLUDING THE AMOUNT OF \$10,500 FOR CATS; AND APPROPRIATION FROM THE SWIMMING POOL FUND IN THE AMOUNT OF \$59,400 FOR THE SWIMMING POOL; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES

WHEREAS, it is necessary that an amendment of the funds to be appropriated for the operation of various departments of the City of Cammack Village for the fiscal year beginning January 1, 2002 and ending December 31, 2002 be made.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas:

SECTION 1: That funds for the fiscal year, beginning January 1, 2002 and ending December 31, 2002 are hereby amended and appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth:




