

AN ORDINANCE APPROPRIATING FUNDS FOR THE FISCAL YEAR JANUARY 1, 2003 THROUGH DECEMBER 31, 2003 FROM THE GENERAL FUND IN THE AMOUNT OF \$417,650; THE SUM OF \$155,098 FOR THE POLICE DEPARTMENT; THE SUM OF \$12,000 FOR THE FIRE DEPARTMENT; THE SUM OF \$8,500 FOR THE PARKS AND RECREATION DEPARTMENT; THE SUM OF \$10,000 FOR THE SWIMMING POOL; THE SUM OF \$75,000 FOR THE SANITATION DEPARTMENT; THE SUM OF \$155,552 FOR THE ADMINISTRATION DEPARTMENT; THE SUM OF \$1,500 FOR MISCELLANEOUS EXPENSES; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND. AN APPROPRIATION FROM THE STREET FUND IN THE AMOUNT OF \$56,800; INCLUDING THE SUM OF \$10,300 FOR C.A.T.A.; AND APPROPRIATION OF \$59,702 FROM THE SWIMMING POOL FUND; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to appropriate funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2003 ending December 31, 2003.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas:

SECTION 1: That funds for the fiscal year, beginning January 1, 2003 and ending December 31, 2003 are hereby appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth:


