

**ORDINANCE 04-08**

AN ORDINANCE REVISING ORDINANCE 03-08 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2004 THROUGH DECEMBER 31, 2004 FROM THE GENERAL FUND FROM THE AMOUNT OF \$385,566 TO THE AMOUNT OF \$448,500; FROM THE AMOUNT OF \$139,546 TO THE AMOUNT OF \$170,000 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$9,585 TO THE AMOUNT OF \$18,000 FOR THE FIRE DEPARTMENT; THE AMOUNT OF \$4,250 TO THE AMOUNT OF \$5,500 FOR THE PARKS AND RECREATION DEPARTMENT; FROM THE AMOUNT OF \$5,000 FOR THE SWIMMING POOL; FROM THE AMOUNT OF \$71,850 TO THE AMOUNT OF \$74,000 FOR THE SANITATION DEPARTMENT; THE AMOUNT OF \$154,205 TO THE AMOUNT OF \$170,500 FOR THE ADMINISTRATION DEPARTMENT; FROM THE AMOUNT OF \$1,130 TO THE AMOUNT OF \$3,000 FOR MISCELLANEOUS EXPENSES; FROM THE AMOUNT OF \$0 TO THE AMOUNT OF \$2,500 FOR SALES TAX; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN AMENDED APPROPRIATION FROM THE STREET FUND FROM THE AMOUNT OF \$58,000 TO THE AMOUNT OF \$64,300, INCLUDING THE AMOUNT OF \$10,300 FOR C.A.T.A.; AN AMENDED APPROPRIATION FROM THE SWIMMING POOL FUND FROM THE AMOUNT OF \$54,502 TO THE AMOUNT OF \$46,000; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

**WHEREAS**, it is necessary to amend the funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2004 ending December 31, 2004.

**NOW, THEREFORE, BE IT ENACTED** by the City Council of the City of Cammack Village, Arkansas;

**SECTION 1:** That funds for the fiscal year, beginning January 1, 2004 and ending December 31, 2004 are hereby amended and appropriated from the General Fund, Pool Fund, and Street Funds in the amount and for the departments as hereinafter set forth;


