

**ORDINANCE 06-11**

AN ORDINANCE REVISING ORDINANCE 05-10 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2006 THROUGH DECEMBER 31, 2006 FROM THE GENERAL FUND FROM THE AMOUNT OF \$432,716 TO THE AMOUNT OF \$538,820; FROM THE AMOUNT OF \$169,170 TO THE AMOUNT OF \$190,000 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$9,410 TO THE AMOUNT OF \$13,000 FOR THE FIRE DEPARTMENT; FROM THE AMOUNT OF \$71,116 TO THE AMOUNT OF \$83,000 FOR THE SANITATION DEPARTMENT; FROM THE AMOUNT OF \$4,200 TO THE AMOUNT OF \$7,000 FOR THE PARKS AND RECREATION DEPARTMENT; FROM THE AMOUNT OF \$5,000 TO THE AMOUNT OF \$71,000 FOR THE SWIMMING POOL; THE AMOUNT OF \$168,820 FOR THE ADMINISTRATION DEPARTMENT; FROM THE AMOUNT OF \$5,000 TO THE AMOUNT OF \$6,000 FOR SALES TAX; ALL PREVIOUSLY DESIGNATED DEPARTMENTAL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN AMENDED APPROPRIATION FROM THE STREET FUND FROM THE AMOUNT OF \$56,424 TO THE AMOUNT OF \$82,000; AN AMENDED APPROPRIATION FROM THE SWIMMING POOL FUND FROM THE AMOUNT OF \$54,350 TO THE AMOUNT OF \$125,000; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to amend the funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2006 ending December 31, 2006.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas;

SECTION 1: That funds for the fiscal year, beginning January 1, 2006 and ending December 31, 2006 are hereby amended and appropriated from the General Fund, Pool Fund, and Street Funds in the amount and for the departments as hereinafter set forth;


