

ORDINANCE 08-08

AN ORDINANCE REVISING ORDINANCE 07-10 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2008 THROUGH DECEMBER 31, 2008 FROM THE GENERAL FUND FROM THE AMOUNT OF \$468,641 TO THE AMOUNT OF \$616,560; FROM THE AMOUNT OF \$195,480 TO THE AMOUNT OF \$243,000 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$164,642 TO THE AMOUNT OF \$188,000 FOR THE ADMINISTRATION DEPARTMENT; FROM THE AMOUNT OF \$5,320 TO THE AMOUNT OF \$32,000 FOR THE FIRE DEPARTMENT; THE AMOUNT OF \$87,460 FOR THE SANITATION DEPARTMENT; FROM THE AMOUNT OF \$5,300 TO THE AMOUNT OF \$48,000 FOR THE PARKS AND RECREATION DEPARTMENT (EXCLUDING SWIMMING POOL); FROM THE AMOUNT OF \$5,000 TO THE AMOUNT OF \$12,500 FOR THE SWIMMING POOL FUND; FROM THE AMOUNT OF \$5,439 TO THE AMOUNT OF \$5,600 FOR SALES TAX; ALL PREVIOUSLY DESIGNATED DEPARTMENTAL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN AMENDED APPROPRIATION FROM THE STREET FUND FROM THE AMOUNT OF \$60,080 TO THE AMOUNT OF \$32,000; AN AMENDED APPROPRIATION FROM THE SWIMMING POOL FUND FROM THE AMOUNT OF \$57,400 TO THE AMOUNT OF \$74,000; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to amend the funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2008, and ending December 31, 2008.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas;

SECTION 1: That funds for the fiscal year, beginning January 1, 2008, and ending December 31, 2008, are hereby amended and appropriated from the General Fund, Pool Fund, and Street Funds in the amount and for the departments as hereinafter set forth;


