

ORDINANCE 09-06

AN ORDINANCE RE-ENACTING ORDINANCE 71-6 WHICH REQUIRES OWNERS OR OCCUPANTS OF PREMISES ABUTTING ON STREETS TO KEEP THE STREET GUTTERS ALONGSIDE THEIR PREMISES CLEAR OF ALL MATTER PREVENTING THE FREE FLOW OF WATER THEREIN AND PROHIBITING OBSTRUCTIONS TO SUCH FLOW AND PRESCRIBING A PENALTY THEREOF FOR ITS VIOLATION; REPEALING ALL ORDINANCES OR RESOLUTIONS IN CONFLICT HEREWITH; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.

WHEREAS, the City Council of the City of Cammack Village, Arkansas previously enacted Ordinance No. 71-6 providing standards for owners and/or occupants of property within the City of Cammack Village, Arkansas in which such property abuts a street within the City of Cammack Village, Arkansas to keep the street gutters alongside such property clear of all matter preventing the free flow of water therein and prohibiting obstructions to such flow and which prescribed a penalty thereof for its violation; and

WHEREAS, the City Council of the City of Cammack Village, Arkansas desires to re-enact, revise and replace Ordinance No. 71-6 with this Ordinance 09-06 so that it can be published and circulated to residents of the City of Cammack Village in the Cammack Periodical.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMMACK VILLAGE, ARKANSAS:

SECTION 1. Requirements to Keep Gutters Free and Clear of Obstructions and/or Debris. The owner or owners, occupant or occupants of any block or lot or part of a block or lot in the City of Cammack Village, Arkansas, abutting on any gutter of any street of the City of Cammack Village, Arkansas shall be and are hereby required to keep said gutter or gutters upon which the premises owned or occupied by said owner or occupant may abut, clean and clear of all obstructions to the free flow of water therein, and any and all persons are hereby prohibited from depositing or permitting any deposit in any street, gutter or gutters of the City of Cammack Village, Arkansas, any matter or debris that will obstruct or cause to be obstructed the free flow of water therein.

SECTION 2. Penalty. Any violation of this ordinance within the City of Cammack Village, Arkansas shall be a misdemeanor and subject to a fine of not less than \$25 per violation.

SECTION 3. Repeal. All ordinances and resolutions in conflict herewith are specifically repealed.

SECTION 4. Emergency Clause. The City Council of the City of Cammack Village, Arkansas finds and determines that an ordinance re-enacting the requirement for its owners and/or occupants of property within the City of Cammack Village, Arkansas to keep the street gutters along their property clear of all obstructions and/or debris that prevents the free flow of


water into such gutters is necessary for the orderly administration and operation of the City of Cammack Village, Arkansas; an emergency is declared to exist and this Ordinance being necessary for the preservation of the public peace, health and safety shall be in full force and effect on or after the 10 day of November, 2009.
