ORDINANCE 13-06

AN ORDINANCE REVISING ORDINANCE 12-03 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2013 THROUGH DECEMBER 31, 2013 FROM THE GENERAL FUND FROM THE AMOUNT OF \$431,550 TO THE AMOUNT OF \$464,025; FROM THE AMOUNT OF \$212,099 TO THE AMOUNT OF \$244,000 FOR THE POLICE DEPARTMENT; THE AMOUNT OF \$3,650 FOR THE FIRE DEPARTMENT; THE AMOUNT OF \$90,360 FOR THE SANITATION DEPARTMENT; THE AMOUNT OF \$9,450 FOR THE PARKS AND RECREATION DEPARTMENT (EXCLUDING SWIMMING POOL); THE AMOUNT OF \$5,000 FOR THE SWIMMING POOL FUND; THE AMOUNT OF \$105,065 FOR THE ADMINISTRATION DEPARTMENT; FROM THE AMOUNT OF \$5,500 TO THE AMOUNT OF \$6500 FOR SALES TAX; ALL PREVIOUSLY DESIGNATED DEPARTMENTAL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN AMENDING APPROPRIATION FROM THE STREET FUND FOR THE AMOUNT OF \$58,350 TO THE AMOUNT OF \$71,000; AN AMENDING APPROPRIATION FROM THE SWIMMING POOL FUND FROM THE AMOUNT OF \$60,625 TO THE AMOUNT OF \$54,000; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to amend the funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2013 and ending December 31, 2013.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas;

SECTION 1: That funds for the fiscal year, beginning January 1, 2013, and ending December 31, 2013, are hereby amended and appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth.
