

**ORDINANCE 15-05**

**AN ORDINANCE REVISING ORDINANCE 14-03 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2015 THROUGH DECEMBER 31, 2015 FROM THE GENERAL FUND FROM THE AMOUNT OF \$449,156.76 TO THE AMOUNT OF \$535,200; FROM THE AMOUNT OF \$222,920 TO THE AMOUNT OF \$274,000 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$3,750 TO THE AMOUNT OF \$4,000 FOR THE FIRE DEPARTMENT; FROM THE AMOUNT OF \$84,167.76 TO THE AMOUNT OF \$85,000 FOR THE SANITATION DEPARTMENT; FROM THE AMOUNT OF \$9,000 TO THE AMOUNT OF \$30,000 FOR THE PARKS AND RECREATION DEPARTMENT (EXCLUDING SWIMMING POOL); FROM THE AMOUNT OF \$7,500 TO THE AMOUNT OF \$20,200 FOR THE SWIMMING POOL FUND; FROM THE AMOUNT OF \$114,819 TO THE AMOUNT OF \$115,000 FOR THE ADMINISTRATION DEPARTMENT; THE AMOUNT OF \$6,500 FOR SALES TAX; ALL PREVIOUSLY DESIGNATED DEPARTMENTAL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN AMENDING APPROPRIATION THE STREET FUND IN THE AMOUNT OF \$56,100; AN AMENDING APPROPRIATION FROM THE SWIMMING POOL FUND IN THE AMOUNT OF \$56,000; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, it is necessary to amend the funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2015 and ending December 31, 2015.

**NOW, THEREFORE, BE IT ENACTED** by the City Council of the City of Cammack Village, Arkansas;

**SECTION 1:** That funds for the fiscal year, beginning January 1, 2015, and ending December 31, 2015, are hereby amended and appropriated from the General Fund, Pool Fund and Street Funds in the amount and for the departments as hereinafter set forth.
