

ORDINANCE NO. 00-3

AN ORDINANCE REVISING ORDINANCE NO. 99-10 TO AMEND THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR JANUARY 1, 2000 THROUGH DECEMBER 31, 2000 FROM THE GENERAL FUND FROM THE AMOUNT OF \$402,100.00 TO THE AMOUNT OF \$383,020; THE SUM OF \$127,595 FOR THE POLICE DEPARTMENT; FROM THE AMOUNT OF \$5,000 TO THE AMOUNT OF \$6,000 FOR THE FIRE DEPARTMENT; FROM THE AMOUNT OF \$5,220 TO THE AMOUNT OF \$8,000 FOR THE PARKS AND RECREATION DEPARTMENT; FROM THE AMOUNT OF \$5,000 TO THE AMOUNT OF \$17,500 FOR THE SWIMMING POOL; THE SUM OF \$67,325 FOR THE SANITATION DEPARTMENT; FROM THE AMOUNT OF \$149,960 TO THE AMOUNT OF \$155,000 FOR THE ADMINISTRATION DEPARTMENT; FROM THE AMOUNT OF \$42,000 TO THE AMOUNT OF \$1,600 FOR THE BOND TRANSFER; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND. AN APPROPRIATION FROM THE STREET FUND FROM THE AMOUNT OF \$54,200 TO THE AMOUNT \$62,200; INCLUDING FROM THE AMOUNT OF \$7,500 TO THE AMOUNT OF \$9,200 FOR C.A.T.A.; AND APPROPRIATION FROM THE SWIMMING POOL FUND FROM THE AMOUNT OF \$54,600 TO THE AMOUNT OF \$71,500 FOR THE SWIMMING POOL; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary that an amendment of the funds to be appropriated for the operation of various departments of the City of Cammack Village for the fiscal year beginning January 1, 2000 and ending December 31, 2000 be made.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas:

SECTION 1: That funds for the fiscal year, beginning January 1, 2000 and ending December 31, 2000 are hereby amended and appropriated from the General Fund, Pool Fund and the Street Funds in the amount and for the departments as hereinafter set forth:


