

ORDINANCE 04-09

AN ORDINANCE APPROPRIATION FUNDS FOR THE FISCAL YEAR JANUARY 1, 2005 THROUGH DECEMBER 31, 2005 FROM THE GENERAL FUND IN THE AMOUNT OF \$416,790; THE SUM OF \$152,925 FOR THE POLICE DEPARTMENT; THE SUM OF \$11,910 FOR THE FIRE DEPARTMENT; THE SUM OF \$3,000 FOR THE PARKS AND RECREATION DEPARTMENT; THE SUM OF \$5,000 FOR THE SWIMMING POOL; THE SUM OF \$73,350 FOR THE SANITATION DEPARTMENT; THE SUM OF \$162,605 FOR THE ADMINISTRATION DEPARTMENT; THE SUM OF \$5,000 FOR SALES TAX; THE SUM OF \$3,000 FOR MISCELLANEOUS EXPENSES; ALL FUNDS APPROPRIATED FROM THE GENERAL FUND; AN APPROPRIATION FROM THE STREET FUND IN THE AMOUNT OF \$57,900, INCLUDING THE AMOUNT OF \$10,300 FOR C.A.T.A.; AND AN APPROPRIATION FROM THE SWIMMING POOL FUND IN THE AMOUNT OF \$54,100; DECLARING AN EMERGENCY AND FOR ALL OTHER PURPOSES.

WHEREAS, it is necessary to appropriate funds to be used for the operation of the various departments of the City of Cammack Village for the fiscal year beginning January 1, 2005 and ending December 31, 2005.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Cammack Village, Arkansas:

SECTION 1: That funds for the fiscal year, beginning January 1, 2005 and ending December 31, 2005 are hereby appropriated from the General Fund, Pool Fund and Street funds in the amount and for the departments as hereinafter set forth:


